It is still fairly confusing when registering for classes, however between the toggling of classes, planning calendar and registration; my suggestion would be to work on streamlining this process to make it more user-friendly to students.

I have been coming to Parkland College on and off since summer 2013 and overall it has been a good experience and I would definitely recommend others come to Parkland. A lot has changed over the years, so that takes some getting used to, but I still like Parkland a lot.

I absolutely love the experience and would recommend Parkland to anyone looking to further their education! Go Cobra's!

Parkland College gave me the opportunity to be a valuable member of our society. After finishing the program here, I look forward to working as a dental hygienist.

You no longer have evening courses for adult students. I find this frustrating as I am forced to take classes online where a large majority of the coursework is teaching myself materials. I completely feel, that if you require students to take math courses in order to graduate you should have a variety of options available for them to choose from not just this is all we have, you can wait until next semester and TRY to find a course that works with your full-time work position and/or schedule.

Dear Parkland, Parkland should use the following way. After parkland got transfer credit from another college for a student, the parkland admission office or whoever took in charge for matching the classes from different colleges or Registrar will give the student credit for the same classes (ESL 101 and ENG 101), (SPE 103 and COM 103) (MAT 102 and MAT electives) are the same. Please do not send the student from department to department. Advisor should give credit ESL 101 as ENG 101 if parkland will allow for student as a rule or policy. For business MAT 110, We need only basic Math (adding, subtracting, dividing and multiplication) only. (High School level only) MAT - 059 and 060 level.

I came to Parkland with an uncertainty on how to continue my secondary education due to person challenges and conflicts. Parkland College and my specific department allowed me to create a course plan that was catered specifically to my needs and gave incredible support. Parkland College gave me a safe space to figure out my career plan while making progress towards my degrees. I probably wouldn't have been able to continue my secondary education without this institution.

There are some overwhelmingly high expectation from the math and sciences departments. While I realize that Parkland takes great pride in their nursing program, a 3 credit biology class for someone that just needs to complete a life science course should not be as in depth as a 4 credit course with a lab designed for students that are pursuing a medical profession. Parkland needs a life science course for those that are just trying to reach their requirements. In regards to math, I feel like the placement test is designed to make students have to take non-credit courses so the college can get more money from enrollment. I was not able to test into college algebra, so I took it at another school and got an "A". I was clearly prepared.

I'm not sure how this would work, but I would greatly appreciate more in person classes. I wanted to register for all in person classes, but in the end, only one was available to me. I feel like there should be an incentive for students to enroll in more in person classes. That way not as many classes will get canceled.

parkland college is really good about helping first generation college students

I returned to college last semester, and it's been hard because the professors aren't actually teaching. We have digital everything, so rather than teaching us, we are given the assignment to complete online and test. To understand the lesson, I have to devote hours to self-teaching. In my opinion, they are relying too heavily on the online software and basically not teaching. When I asked questions in class, I've been told they are too busy with too many classes to slow down. Even when I was pointing out a math mistake on the board. That just made everyone else NEVER ask another question. I feel like I'm really struggling and the only help I get is being told to go to the learning resource center. What's the point of having a professor?

I am starting here at an unusual point in my life. The staff at Parkland have been most helpful, from my first meeting with an advisor to meetings to select courses and any tests needed.

I have been very impressed with the academic faculty and administrative staff at Parkland College. My overall experience as a student has been positive and fruitful to my academic career. As well, my experience as a student worker has been surrounded by professional, compassionate, and supportive staff members who truly care about the success of students and a positive work environment for their colleagues.

I like Parkland College a lot. It's a great college.

Some educators at the school are excellent- while others are harsh, unhelpful, rude, and/or unwilling to work with students who require flexibility. Also, Respondus Lockdown Browser is legitimately unsafe Spyware. It should NOT be used at Parkland, or in general. When a student uses this Lockdown Browser, it has access to every single file in their computer as well as any information linked to any email or account used on that computer. It is unsafe, able to be hacked, and a violation of student privacy and trust. Get rid of it.

Relating to these questions, I feel that the Engineering Pathways program is too strict in its cohort model. I know it isn't just Parklands decision but also UIUC's, but a few years ago you didn't have to retake so many courses to get credit.

The placement exams (math) were not a good experience, we are provided with only a small sheet of plastic and a marker to write with, but no eraser it's a hassle to get up and leave the room during testing to get another sheet to write on (you end up writing a lot for a math test) so, many resort to using their hands and fingers as erasers and it's just very unpleasant.

Parkland is doing a really good job of focusing on the support of its students. It cares that you are there and wants you to succeed. So I am overall very happy with Parkland. I am disappointed in the school's growing use of Cengage online learning which I have found to be an embarrassingly and frustratingly poor educational tool.

The online registration process seemed obtuse and the process of paying for the classes I had registered for was probably the worst experience I have had paying for anything electronically.

Communication has been an issue with parkland since I started, nothing was ever clear, registration is difficult, and constant changes have gotten on my nerves



I've only ever had one instructor who wasn't willing to help me. All of my other instructors have been incredibly helpful and willing to set aside time for me.



What academic program are you currently enrolled in?





How do you primarily take classes at your school?





What is your current age?





What is your gender?




