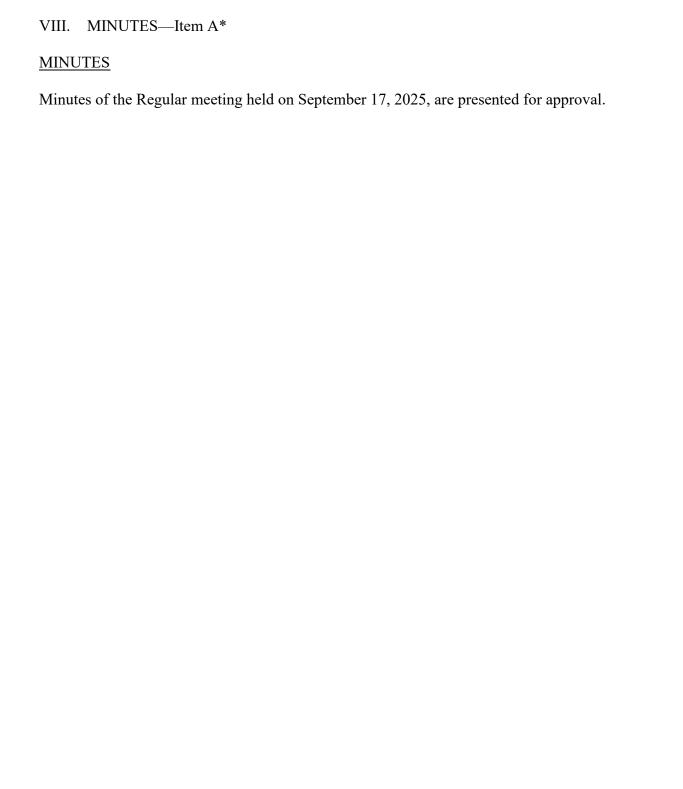

ROLL CALL

The Meeting was called to order by Chair Banks at 7:00 p.m. The meeting was held electronically via Teams and in Room U325, 2400 W. Bradley, Champaign, Illinois. At the direction of Chair Banks, Krystal Garrett, Executive Assistant to the President/Board of Trustees, called the roll of members of the Board. The following Trustees were present: James Ayers, Daniel Marker, Carolyn Ragsdale, Dana Trimble, PascalineGrace Phongo, and Maureen Banks. Also present were President Pamela Lau and representatives of the administration, faculty, staff, and public. Trustee Jarrett Clem was absent. Trustee Green joined the meeting at 7:01 p.m.

PUBLIC SAFETY DEPARTMENT – RESOLUTION

In accordance with the Illinois Compiled Statutes, the Board of Trustees is empowered to appoint sworn members to the College's Public Safety Department. The following individual is being appointed to the full-time, 12-month public safety officer position and is qualified to be a Parkland College Peace Officer.

Gavin Granse – Filling the vacancy created by David Dameron.

Gavin Granse graduated from Urbana High School in Urbana, IL, in 2020. Gavin also attended Culver-Stockton College in Canton, Missouri, in 2020-2021, where he played baseball. He also attended classes here at Parkland College from 2023-2024.

He was hired as a Police Officer at Parkland College in January 2025. Gavin then began the University of Illinois Police Training Institute and graduated on April 24th, 2025.

He went on to complete our field training program in August 2025 and has now been released for solo patrol.

It was moved by Mr. Trimble and seconded by Mr. Marker to approve the Resolution to appoint Gavin Granse as a Peace Officer to the Parkland Public Safety Department.

REPORT FROM THE PRESIDENT OF PCA

Kevin Hastings, President of PCA, stated that there was no report.

PRESIDENT'S REPORT

Dr. Pamela Lau reported on the following:

1. Enrollment – 10th Day numbers

Our 10th Day enrollment census shows that we are up 5.7% in unduplicated headcount compared to last fall. We are at 6355 students this fall; last year we were at 6014 in headcount. We are up 4.3% in FTE.

Some interesting details:

- Online versus in-person: 52% of students are taking only in-person courses, but the 48% who take online classes are taking more credits. Our data shows a 6.6% increase in online FTE.
- Continuing students: Student persistence is an important marker of student success and progress to degree. We have a 13.5% increase in continuing students compared to last year.
- Part-time versus full-time: 66% of our enrolled students are part-time, compared to 65% last year.
- **Age range:** We see an increase of 8.1% in the 17-20 age group (traditional aged) and 12.7% increase in the 25-30 age group (non-traditional).
- Race and ethnicity: If we disaggregate students by race and ethnicity, we see strong increases among Latino/Hispanic students (up 13.3%) and Asian students (up 12%).
- Degree-seeking:
 - o 65% of our students are degree-seeking. Included in the non-degree seeking group are dual credit students and concurrent enrollment students.
 - o Of the degree-seeking students,
 - o 45% are transfer seeking
 - o 35% are in career-oriented programs
 - 15% are pre-Health students (total of 50% of degree-seekers are interested in a work-oriented credential)
 - o 5% are pursuing an Assoc in General Studies
- 2. **Illinois Regional College Fair:** On September 8, Parkland hosted the Illinois Regional College Fair from 6–8 p.m. in the Dodds Athletic Center. This free event catered to high school students and community college transfer students and their families. We had more than 60 institutions representing colleges from across the country as exhibitors, and more than 650 people came onto our campus. Many of these 650 attendees stopped by Parkland tables for information on what we offer. It is events like these that keeps our name and good work out there contributing positively to next fall's 10th Day census count!

Celebrating Our People

- 3. **Forty Under 40:** Every year, Central Illinois Business Magazine sponsors Forty Under 40 awards to celebrate men and women who contribute in significant ways to our community. Two college employees, nominated by their Parkland colleagues, have been selected to receive the 2025 awards. They are:
 - a. Cayla Waters: Cayla is the Associate Director for Contract Training and Professional Development in Community Education. She puts her Master of Arts in Communication and Leadership Studies into practice as she leads strategic planning, program development, and implementation of workforce training initiatives. Her nominators wrote: "What sets Cayla apart is her ability to lead with both heart and hustle. She is a dedicated mom, farm wife, and co-owner of a family farm. Her grounded leadership, deep community ties, and unwavering drive to serve others make her a standout candidate" for this award.

- b. Laura Wright: Laura works in Human Resources as a Labor and Employee Relations Consultant, helping supervisors, managers, union leaders, and employees work together. She holds a Master of Social Work. Before her move to HR, Laura worked in Student Services as an Accessibility Services Specialist. She is recognized by her colleagues for her skillful communication. Her nominators describe her as a quiet powerhouse who works to build a better workplace, stronger campus, and connected community.
 - In addition to Cayla and Laura, we also have an adjunct faculty member among the 40 awardees.
- c. **Jacob Dickey:** Jacob is a well-known local media personality as the meteorologist at WCIA 3 News. He has several Parkland connections. Jacob is an adjunct faculty member: he teaches ESC 101: Introduction to Weather. He started college as a Parkland Pathways student before transferring to the College of ACES at the University of Illinois. And he helps to tell the Parkland story. He hosts the Community College Connections spotlight on WCIA and frequently features Parkland programming.
- 4. **800**th Career Win for Coach Hastings: This past week, we celebrated a new milestone for Volleyball head coach Cliff Hastings. He earned his 800th career victory at the end of August. This victory solidifies Coach Hastings' standing as one of the most successful coaches in NJCAA volleyball history. He built the Parkland volleyball program into one of the nation's finest. Parkland is incredibly fortunate to have Coach Hastings and his coaching staff lead the Cobra volleyball program.

Dr. Trame noted that Coach Hastings has a 92% winning percentage, has won 3 national championships, is a 3-time NJCAA national coach of the year recipient, and recipient of the American Volleyball Coaches Association coach of the year award. Dr. Trame congratulated Coach Hastings noting that he is a great coach and that the athletes leave Parkland well prepared for whatever their future holds.

External Partnerships

5. **FuFeng proposed investment:** In February 2025, the board approved and adopted a property assessment agreement with FuFeng USA Incorporated. This action was taken in conjunction with seven other taxing bodies. The Fufeng company was interested in purchasing property in Douglas County to build a \$750 million corn wet milling and biofermentation manufacturing plant to produce amino acids for livestock feed. Fufeng projected that this investment when fully operational would lead to the employment of 240 people. Last week, we received word from Brian Moody, Executive Director for Douglas County EDC that Fufeng has decided not to move forward with the purchase agreement. The reasons for Fufeng's decision have not been made available to us.

The college continues to seek other opportunities in the biomanufacturing arena.

• Dr. Stuart and Dr. Lau represented Parkland as part of the NSCEB Road Show (National Security Commission on Emerging Biotechnology) roundtable discussions last week where they showcased our work with employers.

• Earlier this week, Drs. Stuart and Sutton participated in the BioInnovations Midwest convening in Omaha, Nebraska and came back with ideas and potential industry connections. We have received designated money to buy equipment and build a bioprocessing lab.

Upcoming Events:

• October 22 – 25: ACCT Leadership Congress in New Orleans. The theme for this year is "Reimagining Community College: Innovation for a Changing World."

Parkland will be presenting. Our session is titled "Speaking the Language of Business: Understanding the Employer Mindset to Drive ROI in Workforce Training." David Charney, faculty program director for the Ford ASSET program, will be our lead presenter with support from our trustees and vice presidents.

FINANCIAL STATEMENTS

Amie Loyd reported that the financial statements for August reflect the results of the operations of the College for the first two months of fiscal year 2026. The revised budget estimates indicate that operating expenses will exceed revenues by \$2,036,766.

- The key factors for the College's operating results in FY2026 will be CPPRT payments, self-funded health claims under the new TPA, and student enrollment.
- The FY2026 unaudited estimated beginning operating fund balance is \$40M. This amount is 58% of current budgeted operating expenditures.
- TheFY2026 tentative budget projected a \$1,997,604 deficit.
- The FY2026 College final budget will be presented in September.
- The FY2025 College audit will be presented in October.
- The TY2025 tax levy estimated amounts necessary will be presented in October.
- The TY2025 final tax levy will be presented in November.
- The annual budget workshop will be presented in February 2026.

PUBLIC HEARING

A public hearing was held on the proposed 2025-2026 (FY2026) budget.

There were no public comments at the hearing.

2025-2026 BUDGET

The final 2025-2026 (FY2026) budget was presented for approval.

It was moved by Mr. Ayers and seconded by Mr. Trimble that the budget for the 2025-2026 year (FY2026) be adopted in accordance with the document that will be incorporated in the official minutes.

The motion carried by the following vote: AYES—Ayers, Green, Marker, Ragsdale, Trimble, Phongo (Advisory Vote), and Banks. NAYS—None. ABSENT: Clem.

PROTECTION, HEALTH, AND SAFETY PROJECTS/CAMPUS MASTER PLAN UPDATE

Protection, Health, and Safety (PHS) project plans are presented annually to the Board. PHS funds have been used to provide much needed structural and mechanical improvements

to the campus. It is proposed that the PHS projects in the FY2026 capital plan be approved for funding purposes.

These projects relate to the following strategic goal:

Goal E: Secure our Future: Parkland College will strive for sustainable fiscal vitality emphasizing a continued investment in the human, technological, physical, and virtual assets of the college.

E4: Maintain sustainable resources and maximize efficiency to support the learning mission of the college.

Requested projects for approval:

Trustee Trimble suggested that we consider increasing the PHS rate in years to come in order to stay on top of deferred maintenance.

It was moved by Mr. Marker and seconded by Ms. Green to approve the Protection, Health, and Safety projects listed above for FY2025 to be filed in accordance with the documents which will be incorporated in the official minutes.

The motion carried by the following vote: AYES—Ayers, Green, Marker, Ragsdale, Trimble, Phongo (Advisory Vote), and Banks. NAYS—None. ABSENT: Clem.

EXEMPT PURCHASE – AGS PRIME SUBSCRIPTION SERVICES

As a condition of the U.S. Department of Labor Employment and Training Strengthening Community College's Training Grant, Parkland College and its partner colleges in the ATOMAT project (Access to Training Opportunities in Manufacturing and Technology) are required to upload participant-level data into the USDOL's Workforce Integrated Performance System (WIPS). Parkland College is the lead college for this project; the partner institutions are Illinois Valley Community College, John A. Logan College, John Wood Community College, Lincoln Land Community College, Rend Lake College, and Shawnee Community College. American Government Services, LLC, has developed a platform that will provide a streamlined process with end-user training and support for the collection and upload of student-level data into the WIPS system each quarter.

This purchase relates to the following strategic goal:

Goal C: Enrich the Community: Parkland College will work collaboratively to enrich the District 505 community.

1. Sustain Parkland College's role as a regional leader in economic and workforce development, forging partnerships with industry and government that spur job creation, expand the workforce pipeline, upskill incumbent workers, accelerate innovation, and foster a thriving entrepreneurial ecosystem within District 505.

Administration recommended renewing the AGS Prime Platform Subscription and Annual Strengthening Community College Program Management System Subscription Services from American Government Services, LLC, Hudson, WI, for a total cost of \$60,012. This subscription provides access to the systems through December 31, 2026. These items are exempt from formal bid requirements per the Illinois Public Community College Act section 805/3-27.1 (f) purchases and contracts for the use, purchase, delivery, movement, or installation of data processing equipment, software, or services and telecommunications and inter-connect equipment, software, and services. Board authorization is requested since the cost exceeds \$20,000. Funds for this purchase are available from the U.S. Department of Labor ETA Strengthening Community Colleges Training Grant.

It was moved by Ms. Green and seconded by Mr. Trimble to approve the purchase of AGS Prime Platform Subscription and Annual Strengthening Community College Program Management System Subscription Services from American Government Services, LLC, Hudson, WI, for a total cost of \$60,012.

The motion carried by the following vote: AYES—Ayers, Green, Marker, Ragsdale, Trimble, Phongo (Advisory Vote), and Banks. NAYS—None. ABSENT: Clem.

APPLICATION OF FUNDS FROM EXTERNAL SOURCES

There were no applications submitted in August.

CLOSED SESSION

Chair Banks stated that the Board would not be going into Closed Session.

PERSONNEL REPORT

It was moved by Mr. Trimble and seconded by Ms. Ragsdale to approve the Personnel Report for September 2025, in accordance with the documents provided to the Board.

Ms. McAndrew reviewed the JEC process to have positions evaluated. She noted that there are four positions this month and two more next month, for a total of six positions that will be upgraded. Every person who has that title/position will receive that upgrade. She noted that external market salary reviews become outdated quickly. As part of the annual JEC process, they have added a market salary component to stay competitive within the market and balance internal equity. She noted that at the last collective bargaining, they made an agreement

that they would go through a review of the annual JEC process to determine if there is anything that needs to be updated. We plan to engage Evergreen Services to help facilitate this review. The goal is to bring that proposal to the Board for approval in October and have that review cycle completed by spring.

The motion carried by the following vote: AYES—Ayers, Green, Marker, Ragsdale, Trimble, Phongo (Advisory Vote), and Banks. NAYS—None. ABSENT: Clem.

TRUSTEE REPORTS

Student Trustee Phongo updated that the Student Government Association (SGA) created an outreach committee to garner feedback from students in an effort to serve students better. She added that today is Constitution Day and SGA passed out cookies as a way to engage with and inform students about the constitution. In addition, this Friday is the first ICCB in-person meeting for student trustees. Trustee Ayers and Chair Banks noted that ICCTA offers an opportunity for student representatives to present and share their experiences. Chair Banks will follow up with Student Trustee Phongo to discuss her interest.

Trustee Ayers noted that there is a joint ACCT/ICCTA Governance Leadership Institute (GLI), which will be held November 13-15, in Naperville. He noted that this meeting is focused on Illinois only and encouraged trustees to attend.

Trustee Green stated that she was thrilled to see the information about the year-round College for Kids (CFK) courses and asked for additional information. Dr. Stuart updated that there will be offerings on the weekends and evenings, and they are currently piloting a few courses throughout the day with the target audience of home-schooled families. It was suggested that we explore sports or physical education camps. Dr. Trame noted that there may be logistical challenges but appreciates the recommendation and will look into it.

Trustee Trimble mentioned that it was great to see the increase in enrollment and acknowledged that this increase represents a lot of work.

ADJOURNMENT

There being no further business to come before the Board, it was moved by Mr. Marker and seconded by Mr. Trimble for adjournment.

FINANCIAL STATEMENTS

The financial statements for September reflect the results of the operations of the College for the first three months of fiscal year 2026. The revised budget estimates indicate that operating expenses will exceed revenues by \$1,765,880.

- The key factors for the College's operating results in FY2026 will be CPPRT payments, self-funded health claims under the new TPA, and student enrollment.
- The FY2026 audited estimated beginning operating fund balance is \$40.3M. This amount is 58% of current budgeted operating expenditures.
- The FY2026 tentative budget projected a \$1,997,604 deficit.
- The FY2026 College final budget was presented in September.
- The FY2025 College audit will be presented in October.
- The TY2025 tax levy estimated amounts necessary will be presented in October.
- The TY2025 final tax levy will be presented in November.
- The annual budget workshop will be presented in February 2026.

FY2025 AUDIT

The FY25 Comprehensive Annual Financial Report (CAFR) will be presented by VP/CFO Amie Loyd and Heather Powell from Forvis Mazars, LLC (formerly BKD).

The Office of Management and Budget (OMB) have not yet finalized the 2025 Compliance Supplement, so the Federal (also known as single audit) section of the report is not included in the annual report and will be issued separately at a later date. The single audit is not due to the federal government until 9 months after year end - so 3/31/2026. Once the Compliance Supplement is released, we will be able to finalize and issue these reports. All agencies receiving federal funding are in the same situation.

This occurred in FY21 as well.

TRUTH IN TAXATION – TAX LEVY ESTIMATED AMOUNTS NECESSARY

Illinois' Truth in Taxation Law requires that taxing districts estimate the amounts of money needed from their tax levy at least 20 days prior to adopting their final annual levy. See 35 ILCS 200/18-55 *et seq*.

Therefore, taxing districts adopting a resolution authorizing the final aggregate tax levy at their November 2025 board meetings should disclose the estimated amounts necessary to be levied at their October 2025 board meetings, assuming there will be at least 20 days between the meetings.

Vice-President of Administrative Services/CFO, Amie Loyd, will present and discuss the estimated amounts of money needed from the upcoming TY2025 Tax Levy.

XI. BUSINESS & FINANCE—Item F

<u>COMPENSATION CONSULTANT – REVIEW AND UPDATE OF PROFESSIONAL</u> <u>SUPPORT STAFF JOB EVALUATION CLASSIFICATION SYSTEM</u>

Parkland College has continued to evolve as an employer in the higher education sector, requiring ongoing analysis and adjustment of compensation structures to remain competitive, equitable, and compliant with applicable employment laws and standards. As workforce expectations shift and financial stewardship remains critical, a comprehensive review of compensation practices is needed to ensure alignment with institutional goals, market trends, and internal equity.

Evergreen Solutions, the College's current compensation consultant, has submitted a proposal to review and update the Professional Support Staff Job Evaluation Classification System (PSS JEC). The review will assess the effectiveness of the current system, ensure market competitiveness, and support equitable pay practices aligned with institutional and Professional Support Staff Collective Bargaining Unit (PSS CBU) goals. Key activities include meeting with College and PSS CBU representatives, analyzing system data, updating class descriptions, assessing internal equity, reviewing Fair Labor Standards Act (FLSA) exemption status, and providing recommendations for job evaluation scoring, classification adjustments, and job structure.

This project supports the following strategic goals:

Goal D: Invest in Our Employees: Parkland College will invest in the enrichment and development of all employees as they fulfill the mission.

4. Sustain competitive compensation and benefits packages that attract new talent, retain existing employees, and ensure competency and excellence of Parkland employees across the institution.

Goal E: Secure Our Future: Parkland College will strive for sustainable fiscal vitality emphasizing a continued investment in the human, technological, physical, and virtual assets of the college.

4. Maintain sustainable resources and maximize efficiency to support the learning mission of the college.

Administration recommends retaining Evergreen Solutions, Tallahassee, FL, for a total cost of \$28,500. This item is exempt from formal bid requirements per the Illinois Public Community College Act, Section 805/3-27.1 (a), contracts for the services of individuals possessing a high degree of professional skill where the ability or fitness of the individual plays an important part. Board authorization is requested since the cost exceeds \$20,000. Funds are available from FY2026 operating budget for this purchase.

MOTION—Move to retain Evergreen Solutions, Tallahassee, FL, for the compensation study and evaluation for a total cost of \$28,500.

XI. BUSINESS & FINANCE—Item G

EXEMPT PURCHASE – CLUB EUROPA

Based on traveler feedback, Parkland College Community Education is planning a 14-day customized Journey to Copenhagen, Oslo, Stockholm, Helsinki, and Tallinn, for 20-24 travelers in June 2026. It includes superior tourist or moderate first-class hotels, meals, deluxe motorcoach services, airport transfers, licensed local guides, overnight ferry from Stockholm to Helsinki, train from Oslo to Stockholm, local taxes, and gratuities for local guides and coach drivers.

Parkland College Community Education works with Club Europa, a tour designer and operator specializing in customized group travel to purchase group travel tours for community members including transportation, accommodations, private and public tours, guides, gratuity, and some meals. Club Europa, a leader in international travel to and through Europe, was founded in 1959 and boasts fifty percent European senior staff with travel experience. Their on-site staff of tour directors, local guides, assistants, and chauffeurs are carefully chosen and trained by Club Europa, guaranteeing the highest quality professional service.

Community Education has developed a reputable and long-standing partnership with Club Europa. They are knowledgeable about our audience, experts in European travel, and have designed high-quality European tours for our community for more than 15 years. Community Education regularly evaluates the program and services and has continued to partner with Club Europa because their programs and services meet or exceed our customers' expectations. This purchase relates to the following strategic goal:

Goal C: Enrich the Community: Parkland College will work collaboratively to enrich the District 505 community.

- 3. Provide and develop relevant credit and non-credit lifelong learning opportunities for District 505, with a particular focus on engaging with historically underserved communities.
- 5. Maintain an open door for the community to visit campus and engage in enriching programs, events, and experiences.

Administration recommends purchasing the group tour service from Club Europa, Urbana, IL, for a total cost not to exceed \$155,000. Items are exempt from formal bid requirements per the Illinois Public Community College Purchasing Act section 805/3-27.1 (a) contracts for the services of individuals possessing a high degree of professional skill where the ability or fitness of the individual plays an important part. Board authorization is requested since the cost exceeds \$20,000. Funds are available from the FY2026 Community Education budget for this purchase.

MOTION— Move to approve the purchase of group tour services from Club Europa, Urbana, IL, for a total cost not to exceed \$155,000.

XI. BUSINESS & FINANCE—Item H

LEASE AGREEMENT - THE ATKINS GROUP (TAG)

Parkland College Community Education will lease the fenced parking lot from The Atkins Group (TAG) Warehouse, LLC, at 2309 W. Bloomington Road, Champaign, IL, for the truck driver training program. A State of Illinois approved parking lot is a requirement of the 160 hours of training to obtain a Class A Commercial Driver's License. The lot is used for instruction, hands-on practice, and testing. Students are required to complete 120 hours of observation and behind-the-wheel training, including pre-trip inspections, backing, and parallel parking, which are completed in the parking lot.

Parkland College Community Education currently leases parking lot space from The Atkins Group, and the lease ends February 28, 2026. The rental lot is fenced-in and provides a convenient location. It is also safe for the students and equipment. The Lessor will perform exterior pavement replacement during the term of the lease.

The three-year lease spans from March 1, 2026, through February 28, 2029. Rent will cost \$4,822.25 per month for the first year, \$4,966.92 per month for the second year, and \$5,115.93 per month for the third year, for a total cost of \$178,861.20.

Goal C: Enrich the Community: Parkland College will work collaboratively to enrich the District 505 community.

- 1. Sustain Parkland College's role as a regional leader in economic and workforce development, forging partnerships with industry and government that spur job creation, expand the workforce pipeline, upskill incumbent workers, accelerate innovation, and foster a thriving entrepreneurial ecosystem within District 505.

Funds are available from the SWFT grant and Community Education budget.

In addition to providing Internet access to Parkland, the ICN office has been a valuable resource to the College. By housing the regional office of ICN, we have quick access to assistance when issues arise, which helps to maintain a strong, reliable network for Parkland College.

Goal E: Secure our Future: Parkland College will strive for sustainable fiscal vitality emphasizing a continued investment in the human, technological, physical, and virtual assets of the college.

2. Create an environment of accessible technology that supports and secures the college's learning experiences, business operations, and digital assets.

- 3. PREMISES: The College agrees to provide for use by the State certain real property consisting of approximately 560 square feet located at first floor of Parkland College, 2400 W. Bradley Ave, X-131 and X-132, Champaign, IL 61821-1899, hereinafter called "Premises". The State shall have available for its use parking for three (3) vehicles.
- 4. TERM: The term of this Agreement is for sixty (60) months commencing October 1, 2025, and expiring September 30, 2030.
- 5. HOLDOVER: If, after expiration of the Agreement, the State retains possession of the Premises, the Agreement shall continue in full force and effect on the same terms and conditions except the Agreement shall be on a month-to-month basis until terminated or renegotiated.
- 6. RENT: The State shall pay rent to the (City/County/Township/Etc.) in accordance with the attached Exhibit C. Rent shall be paid monthly, in arrears, subject to legislative appropriation, by State warrant. Send payment to: Community College District #505, Parkland College, 2400 Bradley Ave, Champaign, IL 61821-1899, attn Chris Randles.
- 7. AVAILABILITY OF APPROPRIATIONS; SUFFICIENCY OF FUNDS: This Agreement is contingent upon and subject to the availability of sufficient funds. The State may terminate or suspend this Agreement, in whole or in part, without penalty or further payment being required, if (i) sufficient State funds have not been appropriated to the State [or sufficient Federal funds have not been made available to the State by the Federal funding source], (ii) the Governor or the State reserves appropriated funds, or (iii) the Governor or the State determines that appropriated funds [or Federal funds] may not be available for payment. The State shall provide notice, in writing, to College of any such funding failure and its election to terminate or suspend this Agreement as soon as practicable. Any suspension or termination pursuant to this Section will be effective upon College receipt of notice.
- 8. USE OF PREMISES: The State agrees to use the Premises solely for the purpose of conducting State business.
- 9. TERMINATION: Either party has the option to terminate this Agreement at any time by giving one hundred twenty (120) days' written notice prior to termination.

- 10. MAINTENANCE & OPERATING FEES: The College shall be responsible for all maintenance and repairs of the Premises and any parking facilities. In addition to maintenance and repairs, the College will also be responsible for the provision of services including, but not limited to, all utilities (gas, electricity, and hot/cold potable water) bulb replacement and other lighting repairs, janitorial and related supplies and commodities, scavenger service, pest control, snow and ice removal from sidewalks and parking area, and maintenance and monitoring of any/all security systems. The State shall be responsible for maintaining its own equipment.
- 11. MODIFICATION: State will not make any modifications to the Premises without the prior written consent of the College.
- 12. AUDIT/RETENTION OF RECORDS (30 ILCS 500/20-65) The College and its subcontractors shall maintain books and records relating to the performance of the Agreement and necessary to support amounts charged to the State under the Agreement. Books and records, including information stored in databases or other computer systems, shall be maintained by the College for a period of three years from the later of the date of final payment under the Agreement or completion of the Agreement, and by the subcontractor for a period of three years from the later of final payment under the term or completion of the subcontract. Books and records required to be maintained under this section shall be available for review or audit by representatives of: the Procuring Agency, the Auditor General, the Executive Inspector General, the Chief Procurement Officer, State of Illinois internal auditors or other governmental entities with monitoring authority, upon reasonable notice and during normal business hours. The College and its subcontractors shall cooperate fully with any such audit and with any investigation conducted by any of these entities. Failure to maintain books and records required by this section shall establish a presumption in favor of the State for the recovery of any funds paid by the State under the Agreement for which adequate books and records are not available to support the purported disbursement. The College or subcontractors shall not impose a charge for audit or examination of the College books and records.
- 13. FREEDOM OF INFORMATION ACT: This Agreement and all related public records maintained by, provided to or required to be provided to the State, are subject to the Illinois Freedom of Information Act notwithstanding any provision to the contrary that may be found in this Agreement.
- 14. CONTRACTUAL AUTHORITY: CMS, as Lessee, shall be the only State entity responsible for payment under this Agreement, unless said Agreement is also signed by the Using Agency. In that case, the Using Agency shall be the only State entity responsible for payment under the Agreement.
- 15. OPERATION OF PROGRAMS: The parties' respective programs and operations are to function as complete separate entities, with no overlap of authority, duties, or responsibilities other than those contained in this Agreement.
- 16. ASSIGNMENT: The State shall not assign or sublease its rights under this Agreement.
- 17. EXHIBITS: The following Exhibits are appended hereto and by reference made a part of this Agreement: Exhibit G Disclosure Statement; Standard Certifications for Intergovernmental Agreements; Exhibit I Federal Taxpayer Identification Number and IRS Form W9; Exhibit K Disclosure of Business Operations with Iran.
