I. A public hearing to approve a proposed property tax levy increase for COMMUNITY COLLEGE DISTRICT NO. 505 (PARKLAND COLLEGE) COUNTIES OF CHAMPAIGN, COLES, DEWITT, DOUGLAS, EDGAR, FORD, IROQUOIS, LIVINGSTON, MCLEAN, MOULTRIE, PIATT, VERMILION AND STATE OF ILLINOIS for 2024 will be held on Wednesday, November 20th, at 7:00 P.M., prevailing time, Parkland College, Room U325, 2400 West Bradley Avenue, Champaign, Illinois; and electronically via teams. II. The corporate and special purpose property taxes extended for 2023, exclusive of election costs, were Thirty-Three Million Two Hundred Twenty-Seven Thousand Twenty-Nine Dollars (\$33,227,029).

The proposed corporate and special purpose property taxes to be levied for 2024, exclusive of election costs, are Thirty-Seven Million Three Hundred Sixty-Five Thousand dollars (\$37,365,000). This represents a Twelve and Forty-Five hundredths percent (12.45%) increase over the previous year.

III. The property taxes extended for debt service and public building commission leases for 2023, exclusive of election costs, were Six Million Seventy-Seven Thousand One Hundred Seventeen Dollars (\$6,077,117).

The estimated property taxes to be levied for debt service and public building commission leases for 2024, exclusive of election costs, are Six Million Three Hundred Forty Thousand Thirty-Five Dollars (\$6,340,035). This represents a Four and Thirty-Three hundredths percent (4.33%) increase from the previous year.

IV. The total property taxes extended for 2023, exclusive of election costs, were Thirty-Nine Million Three Hundred Four Thousand One Hundred Forty-Seven Dollars (\$39,304,147).

The estimated total property taxes to be levied for 2024, exclusive of election costs, are Forty-Three Million Seven Hundred Five Thousand Thirty-Five Dollars (\$43,705,035). This represents an Eleven and Twenty hundredths percent (11.20%) increase compared to the previous year.
