Any bid not received by said time and date will not be considered. Bids sent by facsimile machine or email will not be accepted.

Prices and Payments:

1. All bid prices shall be complete and include warranty, delivery and installation to Parkland College, 2400 West Bradley Avenue, Champaign, Illinois 61821. Delivery and labor for installation must be coordinated with Parkland College staff.
2. Contract will be an official Parkland College purchase order to be issued after approval of the bid by the Board of Trustees.
3. Payment shall be made in accordance with these specifications and the bid proposal submitted by the bidder. Bid will be valid for a period of sixty days from date of bid opening.
4. Any exceptions or deviations from the bid specifications must be addressed in writing and submitted with the bid.
5. Parkland College is tax exempt. A copy of the exemption certificate will be furnished on request.

Any bid not received by said time and at said place will not be considered. Bids sent by facsimile machine or email will not be accepted. The bids will be publicly opened and announced at 2:00 p.m., Tuesday, July 6, 2021, Room U144 on the Parkland College campus. No decision will be made at that time.

Scope

This specification is written around specific needs of the college and has been done to establish a certain standard of performance. It is the intent of Parkland College to purchase one static ambulance simulator used for high fidelity pre-hospital simulations that meets the following specifications and requirements.

Purpose

The purpose of these specifications is to describe an ambulance simulator which will be used for simulation for EMT, Paramedic, or other allied health profession students enrolled in any Health Professions programs

General

This is a specification for a newer ambulance simulator. Bidders must unequivocally answer all questions yes or no. Any unanswered questions will be considered noncompliant and nonresponsive and subject to rejection.

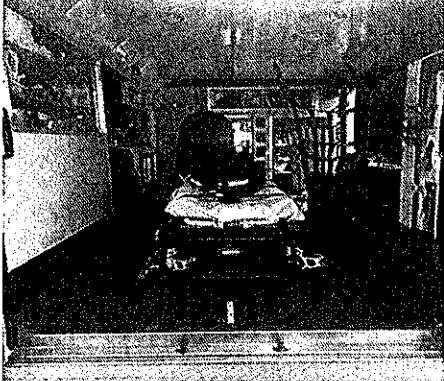
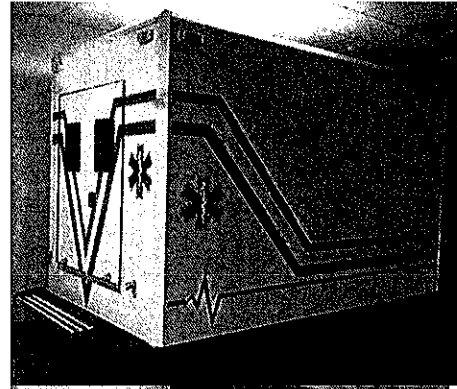
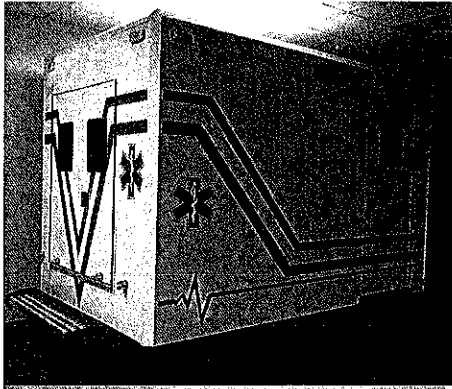
