Any bid not received by said time and date will not be considered. Bids sent by facsimile machine or email will not be accepted.

No information regarding the recommendation to the Board of Trustees will be released until after the Board of Trustees meet on April 26, 2023.

- All bid prices shall be complete and include warranty on parts & service, removal and disposal of old unit, delivery, and installation of new unit to Parkland College, 2400 West Bradley Avenue, Champaign, Illinois 61821. Delivery date installation must be coordinated with Parkland College staff.
- 2. Contract will be an official Parkland College purchase order to be issued after approval of the bid by the Board of Trustees.
- 3. Payment shall be made in accordance with these specifications and the bid proposal submitted by the bidder. Bid will be valid for a period of sixty days from date of bid opening.
- 4. Any exceptions or deviations from the bid specifications must be addressed in writing and submitted with the bid.
- 5. Parkland College is tax exempt. A copy of the exemption certificate will be furnished on request.

Any bid not received by said time and at said place will not be considered. Bids sent by facsimile machine or email will not be accepted. The bids will be publicly opened and announced at 2:00 p.m., Wednesday, March 22, 2023, Room A108 on the Parkland College campus. No decision will be made at that time.

# **Scope**

This specification is written around specific needs of the college and has been done to establish a certain standard of education and training for agriculture technology students. It is the intent of Parkland College to purchase a John Deere Utility Terrain Vehicle (UTV) to educate and train agriculture technology students that meets the following specifications and requirements.

### **Purpose**

The purpose of these specifications is to provide accurate modern precision technology training tools to students who are currently enrolled in agriculture technology programs. This particular vehicle has specifications that allow Parkland to train and educate students on varying technologies from different companies in a cost-effective manner.

## <u>General</u>

These are the specifications for a UTV that will allow us to use modern precision technology for agriculture technology students with John Deere Technology. Bidders must answer all questions. Any unanswered questions will be considered noncompliant and nonresponsive and subject to rejection.
