B. Illinois Residency Verification

The Illinois Student Assistance Commission (ISAC) requires independent students to verify Illinois residency.

“RESIDENTS OF ILLINOIS” is defined as: “An independent student who resides in Illinois (at the time of application), and has so resided for a period of twelve continuous months immediately prior to **September 1, 2020**.”

You must submit a copy of one of the acceptable documents listed below with a date of issuance between **September 1, 2019 and September 1, 2020**.

C. Identity and Statement of Educational Purpose

The student must appear in person at Parkland College to verify his or her identity by presenting a valid government-issued photo identification (ID), such as, but not limited to, a driver's license, other state-issued ID, or passport.
