## **B. Illinois Residency Verification**

The Illinois Student Assistance Commission (ISAC) requires independent students to verify Illinois residency.

"RESIDENTS OF ILLINOIS" is defined as: "An independent student who resides in Illinois (at the time of application), and has so resided for a period of twelve continuous months immediately prior to **September 1, 2019.**

## C. Identity and Statement of Educational Purpose
