Dear Anita Bath:

This is to acknowledge that Parkland College District No. 505 is in receipt of your Freedom of Information Act (FOIA) request received on October 16, 2025, for the following records:

- "1. All payroll records for Mr. Stuber, including pay stubs, salary information, and any overtime or bonus payments.
- 2. All timecards or attendance records documenting hours worked during this period.
- 3. Any and all documents, emails, or authorizations permitting Mr. Stuber to use Parkland College computers, printers, or other resources for work or business related to the Village of Tolono or the Mayor of Tolono.
- 4. All emails sent to or from Mr. Stuber's Parkland College-issued email account, including attachments, during the specified time period.
- 5. All reimbursement records made to or requested by Mr. Stuber, including mileage, travel, meals, supplies, or any other expenses.
- 6. Any conflict of interest disclosures, outside employment authorizations, or related ethics forms filed by or concerning Mr. Stuber.
- 7. Any disciplinary records, internal investigations, or correspondence involving the use of Parkland College resources for non-college business, if applicable."
