RE: Freedom of Information Act Request

Dear Mr. Campo:

This is to acknowledge that Parkland College District No. 505 is in receipt of your *Freedom of Information Act* (FOIA) request dated July 2, 2019 received in my office at 9:54 p.m. via electronic mail. As the Vice President for Communications and External Affairs, I am responsible for processing requests for public information for the College, pursuant to *the Illinois Freedom of Information Act*, 5 ILCS 140/1 et seq. In your e-mail, you requested that the College make available the following records:

Request:

- "1. A full listing of all positions assigned to the college's Human Resources and Payroll offices with titles of positions and annual compensation.
- 2. A full listing of all positions not assigned to the college's HR/Payroll offices but who provide dedicated support to those office; i.e., any IT positions that are dedicated to HR/Payroll.
- 3. An organizational structure for these positions that reflects reporting lines."

Parkland College's Response:

I have attached a document we believe to be fully responsive to your request. The college did receive duplicate requests for identical information from you during the five-business day response period, which included the Independence Day holiday. The college interpreted those as multiple attempts for the same request.

As Vice President for Communications and External Affairs, I am responsible for granting and denying the requests for records under the *Freedom of Information Act*. Please be aware that this response to your request is pursuant to my understanding of your FOIA request. If I have misunderstood your request, please let me know as soon as possible so I may provide the correct information.

Finally, if you believe that this response constitutes a denial of your request, you have the right to have this response reviewed by the Public Access Counselor (PAC) at the Office of the Illinois Attorney General. 5 ILCS 140/9.5(a). You can file your Request for Review with the PAC by writing to:

You also have the right to seek judicial review of this response by filing a lawsuit in the State circuit court. $5 \times 140/11$.
