Dear Mr. Bauman:

This is to acknowledge that Parkland College District No. 505 is in receipt of your *Freedom of Information Act* (FOIA) request dated August 21, 2018 received in my office at 3:51 p.m. on August 21, 2018 via electronic mail. As the Vice President for Communications and External Affairs, I am responsible for processing requests for public information for the College, pursuant to *the Illinois Freedom of Information Act*, 5 ILCS 140/1 et seq. In your e-mail, you requested that the College make available the following records:

Initial request:

"1. The Chronicle requests an electronic copy of a salary/wage/compensation dataset/database for all employees who earned compensation from:

Parkland College

The Chronicle requests the salary/wage/compensation dataset(s)/database(s) encompassing the three (3) most recently completed reporting periods (either fiscal or calendar year).

For instance, at this date, if your institution tracks compensation on fiscal-year basis, and the most recent and available "fully completed" datasets/databases span fiscal years 15-16, 16-17, 17-18, we request those records. On the other hand, if your institution records compensation on calendar year basis, and the most recent and available "fully completed" datasets/databases span calendar year 2015, 2016 and 2017, we request those records.

*When you send us this dataset(s)/database(s), please note over which periods these records span.

If possible, these dataset(s) should contain, but not be limited to, the following fields:

- employee name (or first, last, and middle in separate fields)
- job code
- job title
- full or part time indicator (or FTE number of hours per week)
- department
- bargaining unit
- campus location (or address)

- original hire date

- appointment type

- *And If possible, I request that these records be provided in an electronic format that can be imported into standard database software, such as Excel, Access or SQL open-source software. If that is not possible, I request that this data be supplied in a common electronic form using delimited text file(s), such as tab-delimited or comma-delimited.
- *I am also requesting any lookup tables, field layouts code sheets or other documents needed to interpret the data, if applicable.
- *I would prefer the request be filed electronically, by e-mail attachment if possible or CD-ROM if not. Please send all requested items via email to dan.bauman@chronicle."

Parkland College's Response:

The college has provided the attached Excel document that is responsive to your request. All fields that are tracked within our system have been included. Pursuant to 5 ILCS 140/7(b), and as defined in 5 ILCS 140/2(c-5), employee identification numbers are exempt from disclosure and were not provided.

As the Vice President for Communications and External Affairs, I am responsible for granting and denying the requests for records under the *Freedom of Information Act*. Please be aware that this response to your request is pursuant to my understanding of your FOIA request. If I have misunderstood your request, please let me know as soon as possible so I may provide the correct information.

Finally, if you believe that this response constitutes a denial of your request, you have the right to have this response reviewed by the Public Access Counselor (PAC) at the Office of the Illinois Attorney General. 5
