This is to acknowledge that Parkland College District No. 505 is in receipt of your Freedom of Information Act (FOIA) request received January 27, 2021, via electronic mail for the following:

- "1) How much is Finney being paid to teach for the Spring semester 2022?
- 2) A copy of the contract employing Finney
- 3) Course titles for courses he is facilitating."

Attached you will find a .PDF document that is fully responsive to requests #1 and #3. The college has redacted personally identifiable information such as personal phone numbers pursuant to 5 ILCS 140/7/(1)(c), which explicitly exempts from disclosure personal information within public documents which, if disclosed, would "constitute a clearly unwarranted invasion of personal privacy."
