RE: FOIA Request

Dear Mr. Koprowski:

This letter is in response to your Freedom of Information Act (FOIA) request received by the college on June 7, 2023, for the following records:

"Documents, and other records which identify by name (a) the employees of the Theater Department who report to Brian Morgan, Theater Director, Room C175, and (b) the names of those employees who have reported to him during the last 36 months. As the university is a government institution, (c) we also request the salaries and pay schedules of each of those named employees and copies of their job applications and resumes. SSNs may be redacted per the statute."

On June 13, 2023, the college communicated with you via electronic mail to inform you it was extending the response period by five business days pursuant to 5 ILCS 140/3(e), with a new response deadline of June 21, 2023.

Your request has been granted in part and denied in part. I have attached a .PDF file totaling 212 pages with the responsive records. Personal information, such as home addresses and personal email addresses have been redacted pursuant to 5 ILCS 140/7(1)(c), which exempts from disclosure, "personal information contained within public records, the disclosure of which would constitute a clearly unwarranted invasion of personal privacy." No records have been withheld in their entirety.

As the college's Freedom of Information Act Officer, I am responsible for granting and denying the requests for records under the Freedom of Information Act. Please be aware that this response to your request is pursuant to my understanding of your FOIA request. If I have misunderstood your request, please let me know as soon as possible so I may provide the correct information.

Finally, if you believe that this response constitutes a denial of your request, you have the right to have this response reviewed by the Public Access Counselor (PAC) at the Office of the Illinois Attorney General. 5 ILCS 140/9.5(a). You can file your Request for Review with the PAC by writing to:

You also have the right to seek judicial review of this response by filing a lawsuit in the State circuit court. 5
