This is to acknowledge that Parkland College District No. 505 is in receipt of your *Freedom of Information Act* (FOIA) request dated March 2, 2020 at 8:47 a.m. via electronic mail.

As the Vice President for Communications and External Affairs, I am responsible for processing requests for public information for the College, pursuant to *the Illinois Freedom of Information Act*, 5 ILCS 140/1 et seq. In your original request you asked that the College make the following records available:

- 1. Copies of all job sign in sheets and/or employee verification sheets in which this project and/or any solar projects were discussed
- 2. Copies of any signed or tentative contract documents between Parkland Community College and any solar projects.
- 3. Copies of any and all Certified Payroll documents regarding any solar work being performed at Parkland Community College.

Parkland College's Response:

The College has attached three .PDF documents that are responsive to your request.
