As the Vice President for Communications and External Affairs, I am responsible for processing requests for public information for the College, pursuant to *the Illinois Freedom of Information Act*, 5 ILCS 140/1 et seq. In your e-mail, you requested that the College make available the following records:

Request:

- "- The amount spent by the college for each athletic team on travel expenses for the 2017-18 and 2018-19 school years, the source of those funds, and the number of off-campus trips taken in relation to each team;
- The amount of funds budgeted by the college for the operation of the Alpha Psi Eta chapter of Phi Theta Kappa for the 2017-18 and 2018-19 school year, the source of those funds, and the amount actually spent by the college for those two school years in relation to this program;
- The amount of funds budgeted by the college for the operation of all other recognized student organizations for the 2017-18 and 2018-19 school years, the source of those funds, and the amount actually allocated toward and spent by each recognized student organization during those two school years;
- The number of off-campus trips taken by each recognized student organization, as reported to the Office of Student Life, for the 2017-18 and 2018-19 school years.

Please provide these records electronically in an excel spreadsheet or a similar comma or tabdelimited format."
