- Start date

Please include compensation for any and all appointed officials as well.

Please provide these records electronically in a spreadsheet or delimited text format (such as an Excel file, xlsx, xls, csv or txt file extensions). Please do not respond with paper, scanned/photocopied or pdf documents if at all avoidable. (Section 6(a) of the Illinois Freedom of Information Act states: "When a person requests a copy of a record maintained in an electronic

format, the public body shall furnish it in the electronic format specified by the requester, if feasible.")

Finally, please respond by replying directly to this email with the requested files attached."
