

Executive Summary

During fiscal year 2022, final allocations of COVID-based relief funding were distributed; multiple new and continuation awards from the state were received; successful applications for apprenticeships and bridge programs were developed; and Parkland was awarded a competitive, multi-year federal childcare grant.

In FY22, Parkland received \$817,849 in COVID relief funds via the U.S. Department of Education, the Illinois Community College Board, and the Illinois Emergency Management Agency. These funds, totaling over \$25 million over the course of the pandemic, were used to offset losses incurred due to the COVID-19 pandemic.

Parkland also received several continuation grants for state programs that fund important programs for the Parkland College community. These include awards to the Workforce Equity Initiative program (Parkland SWFT); Parkland's Highway Construction Careers Training Program (HCCTP); the Migrant Education Program (MEP); and the Customized Apprenticeship Programming – Information Technology (CAP-IT).

In addition to the CAP-IT program, Parkland was awarded a variety of other bridge, transition, and apprenticeship funds, including four awards from the Illinois Community College Board focused on competency-based education, bridges to education, and developmental education transitions. These grants will lay the groundwork for larger applications and initiatives at the state and federal level.

In September 2021, the college was awarded a Child Care Access Means Parents in School (CCAMPIS) grant from the U.S. Department of Education; this \$327,800 award provides funds for Parkland students to receive free childcare at Parkland and included renovation funds for Parkland's Child Development Center. These federal multiyear awards are very competitive, but the hope is that Parkland can apply for continuation funding once the current grant period is complete.

The grants office continued meeting its internal goals for FY22 as the number of grants applications, success rate of applications, diversity of areas awarded, and total awarded amount were all at or above our five-year averages.





E2. Utilize our strategic technology plan to support all areas of the college.


E4. Develop and implement external funding plans to support key college projects and offset declining government support using Foundation fundraising, public/private partnerships, and alumni outreach.





COVID-19 Relief Funding

Since the beginning of the COVID-19 pandemic, Parkland has received pandemic relief funding from various state and federal agencies. These non-competitive grants and rebates have been awarded to help offset the costs of responding to the pandemic and the losses incurred due to decreased enrollment related to COVID-19. Funds have been used to purchase supplies, pay contracted staff to monitor doors for vaccine/test status, digitize the campus for remote instruction, etc. The following tables provide an overview of the over \$25 million of COVID relief funding Parkland has received.

Illinois Arts Council Agency (IACA): FY22 Summer Youth Employment in The Arts Grant

Contact: Lisa Costello—Giertz Gallery

Grant Overview: This grant program provides funds to Illinois not-for-profit arts organizations to support summer employment opportunities for high school students or recent high school graduates interested in careers in the arts. Students gain skills and knowledge in each area of the Giertz Gallery. This grant furthers the goal of the art gallery by attracting students and other community members to the gallery.

Funding Amount: \$4,485

Illinois Arts Council Agency (IACA): General Operating Support (GOS) Grant

Contact: Lisa Costello—Giertz Gallery

Grant Overview: This grant provides funds for general operating support for established arts organizations in Illinois that have artistic, educational, and cultural value. Grants support high quality arts programming that broaden opportunities for the public to participate in the arts. Funds from this grant provide general operating support to the Giertz Gallery.

Funding Amount: \$5,700

Illinois Board of Higher Education (IBHE): Illinois Cooperative Work Study (ICWS) Grant

Grant Overview: This grant provides funding for paid student work experiences. Parkland’s goals for this project are to improve partnerships with local businesses, and to meet the academic, financial, and career needs of Parkland’s diverse student population. By increasing the number of work study opportunities available to students—especially those from historically underrepresented groups—Parkland’s BCST department ensures students have access to relevant internship opportunities that provide clear career pathways and promote permanent employment in Illinois.

Funding Amount: \$26,481

Illinois Community College Board (ICCB): Apprenticeship Grant: Customized Apprenticeship Programming—Information Technology (CAP-IT) (DOL-ETA Year 3 funding)

Contact: Derrick Baker—Career & Technical Education

Grant Overview: Year 3 of Parkland’s CAP-IT program will continue utilizing a pipeline of adult education and non-traditional students to apprenticeship opportunities in information technology. Goals include expanding the number of apprenticeships offered; providing more supportive services to students; and increasing the number of employers offering apprenticeships. Employers receive a 50% grant-funded wage share and assistance with the recruitment and hiring of apprentices.

Funding Amount: \$131,000

Illinois Community College Board (ICCB): Apprenticeship Grant: Customized Apprenticeship Programming—Information Technology (CAP-IT) (supplemental)

Contact: Derrick Baker—Career & Technical Education

Grant Overview: This supplemental funding for the CAP-IT program enabled Parkland to expand the CAP-IT initiative to the public sector.

Funding Amount: \$60,000

Illinois Community College Board (ICCB): Competency-Based Education Program Development

Grant Overview: The purpose of this grant is to provide resources necessary for recipients to plan and develop a Competency-Based Education (CBE) program, with guided support from ICCB and its partners. Parkland’s CBE project will focus on program areas within Industrial Technology. Through this grant, Parkland will develop and implement a more flexible, competency-based approach, which will offer flexible schedules and credit for prior learning.

Funding Amount: \$198,883

Illinois Community College Board (ICCB): Developmental Education Innovation Grant for Co-Requisite Implementation

- Grant Overview: This grant provides services that help move students through co-requisite focused developmental education and enrollment into gateway/credit-bearing coursework. Parkland’s co-requisite implementation project will focus on faculty professional development, reducing equity gaps in developmental education, and enhancing wrap-around services for project participants.
- Funding Amount: \$23,718

Illinois Community College Board (ICCB): Early Childhood Access for Equity Consortium

- Grant Overview: Parkland is a member of the Early Childhood Access for Equity Consortium through legislative statute. The goal of this grant is to serve the needs of the incumbent early childhood workforce and the employers of early childhood educators, and to advance racial equity while meeting the needs of employers by streamlining, coordinating, and improving the accessibility of degree completion pathways for upskilling and the sustained expansion of educational pipelines at Illinois institutions of higher education.
- Funding Amount: \$630,964

Illinois Community College Board (ICCB): Early School Leaver Transition Program (ESLTP)

- Grant Overview: The ESLTP grant helps at-risk high school dropouts to complete their education by enabling students to participate in adult education instruction as well as career and work training activities. FY23 program design will target out of school youths—particularly English-language learners, DACA students, DOC re-entry, and those aging out of foster care. ESLTP services prepare youth for college and career, helping young people transition to higher education, full time work, or the military.
- Funding Amount: \$39,279

Illinois Community College Board (ICCB): FY22 Adult Education & Literacy Grant

- Grant Overview: Funding from this grant provides general operating support for Adult Education at Parkland. These grant funds provide comprehensive support to adult students in Illinois by providing educational and literacy services that promote career pathways for adult learners.
- Funding Amount: \$432,240

Illinois Community College Board (ICCB): FY22 Career & Technical Education Perkins Postsecondary Grant

- Grant Overview: The Perkins grant ensures CTE programs are of high quality, align with academic and labor market demands, and provide opportunities for all students, especially those who are underserved. The Perkins grant funding provides instructional supplies, equipment, personnel wages, professional development, etc. Perkins helps equip classrooms and labs with current technology to ensure excellence in teaching and learning to our career/technical students.
- Funding Amount: \$615,581

Illinois Community College Board (ICCB): FY22 Transitional Instruction Innovation Grant

- Grant Overview: Parkland’s project expands Transitional English (TE) instruction to diverse school districts in District 505. The project’s focus is reducing equity gaps in Transitional English instruction leading to completion of gateway courses as well as adoption and testing of innovation models for Transitional English. Parkland coordinates Local Advisory Panel meetings; develops and provides TE professional development opportunities for local/regional high school teachers and administrators; and produces scalable TE curricular framework that is culturally relevant and consistent with statewide TE competencies and student demographics.
- Funding Amount: \$24,005

Illinois Community College Board (ICCB): Innovative Bridge and Transitions Grant

Grant Overview: Parkland’s project helps in-school youth, out-of-school youth, and adults transition into postsecondary education, and from postsecondary education to jobs. Parkland’s “*Seamless Transitions: Computer Literacy & Career Awareness*” project targets youth through summer career camps, while unemployed and underemployed adults will be provided digital literacy assistance and peer mentoring. The project specifically targets low-income, first generation, disabled, and minority populations.

Funding Amount: \$170,000

Illinois Community College Board (ICCB): Lumina Employment Connection Project (ECP) (WEI network)

Grant Overview: The Lumina Foundation's Employment Connection Project funding supplements the Workforce Equity Initiative Grant by helping colleges increase employment outcomes and strengthening connections with employers.

Funding Amount: \$35,000

Illinois Community College Board (ICCB): Workforce Equity Initiative (WEI)

Grant Overview: Building on the success of prior year’s WEI grants, Parkland’s Support for Workforce Training (SWFT) program continues to accelerate participants on a path to high-skilled, high wage, and in-demand occupations. Year 3 of the SWFT program served at least 130 new participants, with a focus on African Americans and other underrepresented and underserved groups. Participants choose from programs within four employment sectors that enable them to earn at least \$19/hour: Healthcare, Construction/Manufacturing, Transportation/Distribution, and Business/IT services.

Funding Amount: \$1,200,000

Illinois Community College Board: Governor’s Emergency Education Relief Funds (GEERF II)

Grant Overview: Parkland’s GEERF II project focuses on providing academic support and social emotional support to students. Academic support is provided through Parkland’s Learning Commons, which provides relevant, accessible, and timely instructional support services to enhance student learning, improve student retention, and encourage student success. Social emotional support is provided through a multi-pronged strategy that will improve mental health awareness; create a culturally informed environment that encourages student access to needed services; enhance accessibility of academic advising and career counseling resources; and develop and enhance partnerships with community organizations that connect students to comprehensive student support.

Funding Amount: \$202,580

Illinois Department of Commerce & Economic Opportunity (DCEO): Line-Item Appropriation Grant

Grant Overview: Funds from this grant will be used for chemistry lab safety improvements. These improvements will provide updated and modern equipment and infrastructure to improve students learning experience and improve lab safety.

Funding Amount: \$100,000

Illinois Department of Human Services and Illinois Network of Child Care Resource & Referral Agencies (INCCRRA): Child Care Workforce Bonus

Grant Overview: Funded through federal pandemic relief funds, this funding provides bonuses for eligible child care staff at the Child Development Center, aiding in staff retention.

Funding Amount: \$21,120

Awarded State Grants

Illinois Department of Transportation (IDOT): FY22 Highway Construction Careers Training Program (HCCTP)

Contact: H. Elise Doody-Jones—Community Education

Grant Overview: This grant provides funds to recruit and train individuals in highway construction industry trades, encouraging participation of women, minorities, and disadvantaged individuals. Funds cover tuition and fees; stipends; training materials and tools; recruitment; mentoring; and other associated costs. Parkland's 14-week highway construction training session prepare students to enter highway construction careers.

Funding Amount: \$382,420

Illinois Emergency Management Agency (IEMA): FEMA Public Assistance Program (App. #1—140127) (additional funds)

Grant Overview: Due to federal rule changes, Parkland received additional funding for newly-eligible costs from its first FEMA Public Assistance Program application.

Funding Amount: \$13,415

Illinois Emergency Management Agency (IEMA): FEMA Public Assistance Program (App. #2—Project #188766)

Grant Overview: Parkland's second round of FEMA funding reimbursed 100% of costs for qualifying purchases. The Illinois Emergency Management Agency functions as the state applicant and is responsible for administering subawards through this program. Parkland requested reimbursement for eligible disinfection/cleaning costs, personal protective equipment and masks, plexiglass barriers, and public signage regarding safe practices during the COVID-19 pandemic.

Funding Amount: \$35,228

Awarded State Grants

Illinois State Board of Education (ISBE): FY22 Facilitating Coordination in Agricultural Education (FCAE)

Grant Overview: FCAE provides technical assistance to all K-12 agriculture teachers in Illinois, provides professional development seminars and workshops, and implements agricultural educator recruitment and retention initiatives. Additionally, FCAE facilitates coordination in community college agricultural programs; university education in agriculture; teacher education programs in agriculture; agriculture workforce knowledge, skills, and talent development; and public and consumer agricultural awareness and advocacy. Parkland is the fiscal agent for this grant.

Funding Amount: \$1,080,000

Illinois State Board of Education (ISBE): FY22 Migrant Education Program (MEP)

Contact: Charles Larenas—Social Sciences and Human Services

Grant Overview: The Migrant Education Program grant provides supplemental education and supportive services to migrant children in central Illinois. With these funds, Parkland's migrant summer program provides comprehensive supportive and academic services to pre-K through 12th grade students, with an emphasis on math, reading, and writing.

Funding Amount: \$354,994

Illinois State Historical Records Advisory Board (ISHRAB): Historical Records Grant Program

Grant Overview: Funding from this grant assists with the identification, preservation, access, and use of historical records in Illinois. With these funds, Parkland will inventory, digitize, preserve, and increase accessibility to the Parkland College student newspaper, The Prospectus. Digitized images will be added to Parkland's institutional repository, SPARK, and shared with the Illinois Digital Newspaper Collections (IDNC) for preservation and increased accessibility.

Funding Amount: \$5,000

Awarded State Grants

Illinois State Library/Secretary of State: Adult Volunteer Literacy Grant (Project READ)

Contact: Tawanna Nickens—Adult Education

Grant Overview: The Adult Volunteer Literacy Grant funds programs that utilize trained volunteers to provide instructional tutoring to adult learners. Funding from this grant supports Parkland's Project READ program, which provides individualized instruction for adults in District 505 who want to improve their reading, math, writing, and language skills.

Funding Amount: \$99,885

Illinois State Library/Secretary of State: Penny Severns Family Literacy Program

Contact: Tawanna Nickens—Adult Education

Grant Overview: This program provides instruction to improve the basic reading, writing skills, math or English language proficiency of parents and children together. Expected outcomes include increasing skills in reading, writing, math, and/or English language; increasing knowledge of parenting; and increasing the ability to use public libraries as resources. To reach these outcomes, Parkland Adult Education works with Champaign Unit 4 School and Champaign Public Library Douglass Branch to provide academics, services, supports and opportunities that lead to improved student learning, stronger families, and healthier communities.

Funding Amount: \$33,002

Awarded Federal Grants

U.S. Department of Education: CARES Higher Education Emergency Relief Fund (HEERF III): SIP Portion (American Rescue Plan allocation)

Contact: Mike Trame—Administration

Grant Overview: The program supports institutions of higher education with the greatest unmet needs related to the COVID-19 pandemic. Funds can be used for virus mitigation, student financial support, expanding high-demand programs, etc.

Funding Amount: \$566,662

U.S. Department of Education: Child Care Access Means Parents in School (CCAMPIS)

Contact: Stephanie Stuart, Adrienne Shockley—Administration, Child Development Center

Grant Overview: The goal of Parkland College’s CCAMPIS project is to help Parkland students who have young children take advantage of the high quality childcare available to them on campus so that these student-parents can successfully complete their college studies; this is accomplished by providing childcare stipends to in-need populations, increasing Parkland’s childcare capacity, reaching out to single parents and pregnant students at Parkland, and providing comprehensive support services for student-parents.

Funding Amount: \$327,800

Awarded Corp./Foundation/Other Grants

Compeer Financial: Vocational Agriculture Education Grant

Contact: Derrick Baker—Career and Technical Education

Grant Overview: These grants invest in vocational education that provide hands-on, technical skills to students. Parkland's agriculture program was selected to apply for funding due to its impact on agriculture and rural communities. Funding will be used to upgrade equipment in precision agriculture and advanced applicator technician programs, as well as for marketing/recruitment for these programs.

Funding Amount: \$75,000

Illinois Green Economy Network (IGEN): Renewable Energy Resources Trust Fund (IEPA funding) – Energy Efficiency Internships

Contact: Jim Bustard—Physical Plant

Grant Overview: This sustainability project funds paid internships for HVAC/Electrical students. Through these internships, students replaced fluorescent lighting in the L wings with LED lighting. Student interns learned the implementation process of various energy efficient lighting and controls, as well as how to calculate energy costs savings.

Funding Amount: \$16,200

Illinois Green Economy Network (IGEN): Renewable Energy Resources Trust Fund (IEPA funding) – General Membership Award
