

Executive Summary

Throughout the 2023 fiscal year (July 1st, 2022 – June 30th, 2023) the Parkland College Office of Grants and Sponsored Programs experienced many successes, transitions, and new developments. FY23 saw the end of most COVID-related grant funds coming into Parkland but also the expansion and continuation of many state-based grants related to workforce development and career training. This year Parkland also received a large federal grant from the U.S. Department of Labor, continued to reengage with applications for congressionally directed grant funding, and developed a new plan for the grants office.

State-based workforce grants continued to provide a large source of external funding to Parkland. The third year of the Workforce Equity Initiative grant through the Illinois Community College Board (ICCB) awarded the college \$1.2 million for a one-year grant period. Additionally, the ICCB granted Parkland \$632,636 through the Pipeline for the Advancement of the Healthcare Workforce (PATH) program. Both grant programs (along with additional funds projected through a state-based clean jobs grant program in FY24) make up Parkland's Support for Workforce Training (SWFT) program. The college also received many other new workforce and bridge grants through the state to enhance and expand career training opportunities.

In September, Parkland was awarded a 4-year \$4,999,726 grant through the U.S. Department of Labor's Strengthening Community Colleges Training program. Parkland's Accelerated Training Opportunities in Manufacturing and Technology (ATOMAT) program develops competency-based education program models and expands capacity for multiple career paths. The program is a consortium with six other community colleges in Illinois and will enroll well over 500 students throughout the grant period.

Over the past two years Parkland has requested funding through congressionally directed community project funding from federal legislators who represent parts of Parkland's district. These funding requests vary based on the committee assignments of each legislator and funding sources available through each department. Congressional appropriations were a source of funding for the college prior to 2010 but had not been available again until recently. Parkland is set to receive funding through this process in FY24.

The conclusion of FY23 coincided with a departmental reorganization wherein the grants department, now officially rebranded as the Office of Grants and Sponsored Programs, added a director position, and plans to add a new full-time staff member in the coming fiscal year. The grants office now operates under the oversight of the Vice President for Strategic Partnerships and Workforce Innovation/Chief Communications Officer. In FY24, the grants office will expand its operations to include more post-award assistance and additional work on developing internal and external partnerships that may lead to external funding.

Throughout FY23, the grants office continued to meet its internal goals. Grants were awarded across all Strategic Plan for Excellence goals; the number of applications submitted stayed at its highest rate over the past decade; the success rate of applications was over 75%; and the amount of funds awarded were well over the five- and ten-year averages for the college.





E2. Utilize our strategic technology plan to support all areas of the college.


E4. Develop and implement external funding plans to support key college projects and offset declining government support using Foundation fundraising, public/private partnerships, and alumni outreach.





Awarded State Grants

Illinois Arts Council Agency (IACA): FY23 General Operating Support (GOS) Grant

Contact: Lisa Costello—Giertz Gallery

Grant Overview: This grant provides funds for general operating support for established arts organizations in Illinois that have artistic, educational, and cultural value. Grants support high quality arts programming that broaden opportunities for the public to participate in the arts. Funds from this grant will provide general operating support to the Giertz Gallery at Parkland College.

Funding Amount: \$5,300

Illinois Arts Council Agency (IACA): Summer Youth Employment in the Arts Program

Contact: Lisa Costello—Giertz Gallery

Grant Overview: This grant provides funds to Illinois not-for-profit arts organizations to support summer employment opportunities for high school students or recent high school graduates interested in working in the arts. Students gain skills and knowledge in each area of the Giertz Gallery. This grant furthers the goal of the art gallery by attracting students and other community members to the gallery.

Funding Amount: \$4,435

Illinois Board of Higher Education (IBHE): Illinois Cooperative Work Study (ICWS) Grant

Contact: Marc Schudel—Business/Computer Science and Technologies

Grant Overview: This grant provides funding for paid student work experiences. Parkland’s goals for this project are to improve partnerships with local businesses, and to meet the academic, financial, and career needs of Parkland’s diverse student population. By increasing the number of work study opportunities available to students—especially those from historically underrepresented groups—Parkland’s BCST department ensures students have access to relevant internship opportunities that provide clear career pathways and promote permanent employment in Illinois.

Funding Amount: \$50,000

Awarded State Grants

Illinois Community College Board (ICCB): Adult Education & Family Literacy Activities (AEFLA)

- Grant Overview: Funding from this continuation grant provides general operating support for Adult Education at Parkland. These grant funds provide comprehensive support to adult students in Illinois by providing educational and literacy services that promote career pathways for adult learners.
- Funding Amount: \$460,874

Illinois Community College Board (ICCB): Adult Education & Literacy—Integrated English Language and Civics Education (IELCE)

- Contact: Tawanna Nickens—Adult Education/CTE
- Grant Overview: Funding from this grant prepares adults who are English Language Learners to enter employment in in-demand occupations. Services provided under this grant include literacy and English language acquisition, civics education, and workforce preparation activities.
- Funding Amount: \$19,960

Illinois Community College Board (ICCB): Apprenticeship Grant: Customized Apprenticeship Programming—Information Technology (CAP-IT) (DOL-ETA, Year 4 funding)

- Grant Overview: Year 4 of Parkland’s CAP-IT program continued to utilize a pipeline of adult education and non-traditional students to apprenticeship opportunities in information technology. This final year of the CAP-IT grant provided student scholarships and apprenticeship opportunities, as well as continuing to utilize supportive services for students.
- Funding Amount: \$68,200

Illinois Community College Board (ICCB): Career & Technical Education Perkins Postsecondary Grant

Grant Overview: The Perkins grant ensures Career & Technical Education programs are of high quality, align with academic and labor market demands, and provide opportunities for all students, especially those who are underserved. The Perkins grant supports CTE programs at Parkland by funding various instructional supplies, equipment, personnel wages, professional development, etc. Perkins helps equip classrooms and labs with current technology to ensure excellence in teaching and learning to our career/technical students.

Funding Amount: \$592,776

Illinois Community College Board (ICCB): College Bridge Program Grant

Grant Overview: Parkland's BEST program aims to address limited exposure to higher education opportunities for minority, low-income, and first-generation students and their families in District 505. Eligible high school seniors will participate in a one-month summer experience focusing on career exploration, First Year Experience course completion, tutoring, and assessment preparation to prepare them for college-level courses.

Funding Amount: \$220,000

Illinois Community College Board (ICCB): Innovative Bridge and Transitions (IBT)

Contact: Nancy Sutton—Administration

Grant Overview: Parkland's Summer Start program provides a summer career pathways experience to high school students, including completion of a First Year Experience (FYE) course. Participants are provided support services, including mentoring, academic advising, and tutoring. By providing seamless transitions for college and career pathways, this project will improve student transitions to and through postsecondary education.

Funding Amount: \$304,000

Illinois Community College Board (ICCB): Mental Health Early Action on Campus Act

Grant Overview: Funding from this appropriation grant addresses gaps in mental health services on college campuses across Illinois. Goals include identifying students with mental health needs and connecting them to services; increasing supportive services on campus; increasing access to clinical mental health services both on college campuses and in the surrounding communities; establishing peer-to-peer support and training; and reducing the potential burden of administrative policies that negatively affect students seeking mental health leave from school.

Funding Amount: \$234,879

Illinois Community College Board (ICCB): Pipeline for the Advancement of the Healthcare Workforce (PATH)

Contact: Alicia Beck, Kim Pankau—SWFT, Health Professions

Grant Overview: Parkland’s PATH project helps meet unmet labor market needs by facilitating student access to academic and social supports, as well as necessary employment skills. In addition to content-specific tutoring, students receive intensive advising and employment skills coaching. Parkland works with local and regional healthcare providers to promote continuing education and upward mobility opportunities for incumbent and underemployed workers in identified areas of need.

Funding Amount: \$632,636

Illinois Community College Board (ICCB): Trades School Program Grant

Grant Overview: The Trades School Grant supports the development and implementation of structured, sustainable career exploration activities that will increase awareness of trades sector career opportunities among middle and high school students and their families in Parkland’s district. Professional development opportunities will be provided for high school teachers and Parkland faculty, focusing on curriculum development and alignment. Parkland will also engage with employers to assist in career preparation workshops and to offer internships to high school juniors and seniors.

Funding Amount: \$398,408

Awarded State Grants

Illinois Community College Board (ICCB): Workforce Equity Initiative (WEI)

Grant Overview: The SWFT program provides funding for short-term training that leads to employment opportunities for in-demand fields with life-supporting wages. Participants receive tuition, books, and fee assistance. SWFT utilizes a “one-stop” location at Parkland to help new students identify which career program they will pursue and provides wrap-around academic and career services to participants, including access to advisors, tutors, peer mentors, academic success coaches, accessibility specialists, and job placement specialists. Employability skills training is also provided to every participant.

Funding Amount: \$1,200,000

Illinois Community College Board: FY23 Early School Leaver Transition Program (ESLTP)

Grant Overview: This grant helps at-risk high school dropouts between the ages of 16 and 21 become reoriented and motivated to complete their education by allowing students to participate in adult education instruction as well as career and work training activities. FY23 program design targeted out of school youths—particularly English-language learners, DACA students, DOC re-entry, and those aging out of foster care. ESLTP services prepare youth for college and career, helping young people transition to higher education, full time work, or the military.

Funding Amount: \$39,279

Illinois Department of Human Services and Illinois Network of Child Care Resource & Referral Agencies (INCCRRA): Strengthen and Grow Child Care Grants (Rounds 5-6)

Contact: Stephanie Stuart, Melissa Munster—Administration, Child Development Center

Grant Overview: This grant provides funding to support high quality childcare and invest in the childcare workforce. Per grant regulations, 50% of funds will be used for staff bonuses and incentives. Remaining funds will ensure the Child Development Center continues to deliver high quality childcare.

Funding Amount: \$73,335

Awarded State Grants

Illinois Department of Transportation (IDOT): FY23 Highway Construction Careers Training Program (HCCTP)

Contact: H. Elise Doody-Jones—Community Education: HCCTP

Grant Overview: This grant provides funds to recruit and train individuals in highway construction industry trades, encouraging participation of women, minorities, and disadvantaged individuals. Funds cover tuition and fees; stipends; training materials and tools; recruitment; mentoring; and other associated costs. Parkland's 14-week highway construction training session prepare students to enter highway construction careers.

Funding Amount: \$382,420

Illinois Emergency Management Agency (IEMA): FEMA Public Assistance Program (App. #3)

Grant Overview: Parkland’s third round of IEMA funding through FEMA’s Public Assistance Program reimbursed 100% of eligible purchases for “safe reopening” during the COVID-19 pandemic. Parkland received reimbursement for eligible disinfection/cleaning costs and personal protective equipment.

Funding Amount: \$7,363

Illinois State Board of Education (ISBE): Facilitating Coordination in Agricultural Education (FCAE)—Local Program Support

Grant Overview: FCAE provides on-site and virtual technical assistance to all K-12 agriculture teachers in Illinois, reviewing and providing curriculum, instructional resources, and associated resources. FCAE provides professional development seminars and workshops and implements agricultural educator recruitment and retention initiatives. Additionally, FCAE facilitates coordination in community college agricultural programs; university education in agriculture; teacher education programs in agriculture; agriculture workforce knowledge, skills, and talent development; and public and consumer agricultural awareness and advocacy. Parkland is the fiscal agent for this grant.

Funding Amount: \$1,024,500

Illinois State Board of Education (ISBE): Migrant Education Program (MEP)

Grant Overview: The Migrant Education Program grant provides supplemental education and supportive services to migrant children in central Illinois. With these funds, Parkland's migrant summer program will provide comprehensive supportive and academic services to pre-K through 12th grade students, with an emphasis on math, reading, and writing

Funding Amount: \$354,994

Illinois State Library/Secretary of State: Adult Volunteer Literacy Grant (Project READ)

Grant Overview: The Adult Volunteer Literacy Grant funds programs that utilize trained volunteers to provide instructional tutoring to adult learners. Funding from this grant will provide support for Parkland's Project READ program, which provides individualized instruction for adults in District 505 who want to improve their reading, math, writing, and language skills.

Funding Amount: \$94,029

Illinois State Library/Secretary of State: Penny Severns Family Literacy Program

Grant Overview: The Penny Severns program provides instruction to improve the basic reading, writing skills, math or English language proficiency of parents and children together. Goals include increasing skills in reading, writing, math, and/or English language; increasing knowledge of parenting; and increasing the ability to use public libraries as resources. To reach these goals, Parkland Adult Education works with partners to provide academics, services, supports and opportunities that lead to improved student learning, stronger families, and healthier communities.

Funding Amount: \$33,081

Local Workforce Development Board 17—LWIA 17 Youth Committee: WIOA Youth Programming

Grant Overview: Funding from this grant supports programs that serve youth within a comprehensive workforce development system. Funding helps Parkland's Adult Education work in recruiting at-risk youth and providing them with the educational and supportive services they require in to successfully complete their high school equivalency test and transition into higher education or careers.

Funding Amount: \$50,000

Awarded Federal Grants

Department of Labor—Employment and Training Administration (DOL-ETA): Strengthening Community Colleges Training Grants—Access to Training Opportunities in Manufacturing and Technology (ATOMAT)

Contact: Nancy Sutton—Administration, Beth Bachtold—Humanities

Grant Overview: Targeting advanced manufacturing and information technology, this consortium grant, led by Parkland, is developing competency-based education program models for Computer User Support Specialist, Industrial Maintenance, and Welding; increasing the capacity of programs; and engaging new community partners by providing referrals to the colleges or needed services to the students. Target outcomes for equity include enrolling 750 students from the target populations over four years. The project will also identify community partners that can assist colleges in supporting students, and to create a model for community partner mapping that can be used in all Illinois community colleges.

Funding Amount: \$4,999,726

National Science Foundation (NSF): Research Experiences for Undergraduates (REU) Supplemental

Grant Overview: This grant provides supplemental REU funding to host a STEM career exploration and REU awareness event for area early-stage college and high school students. The goal of this one-day event is for these students to learn about and encourage participation in undergraduate research opportunities as part of their journey to becoming a STEM professional.

Funding Amount: \$16,021

U.S. Department of Justice—Office of Justice Programs: Bulletproof Vest Partnership

Grant Overview: This grant provides a 50% reimbursement to police departments for the purchase of bulletproof vests purchased for law enforcement officers. Parkland's Public Safety department purchases new vests on rotation on an annual basis, and this grant will offset those costs.

- Grant Overview: This initiative ensures high school students obtain an industry-recognized credential upon graduation, along with assured entry into selective admissions Health Professions programs. Facilitating the integration of CCPE into high schools, alongside smooth transitions to Parkland's certificates and AAS programs, will foster diversity within targeted programs. The aim is to equip students for sought-after high-skilled jobs and related career paths.
- Funding Amount: \$24,000

Gene Haas Foundation: Post-Secondary Program Scholarships and Sponsorship Grant

- Grant Overview: The Gene Haas Foundation’s goal is to build skills in the machining industry by providing scholarships for CNC machinist training. This grant primarily provides funding for student scholarships, with limited funds for competition sponsorships, personal tools, and CNC Machinist credentialing.
- Funding Amount: \$10,000

Illinois Green Economy Network (IGEN): FY23 Supplemental Funding Grant

- Grant Overview: This funding provides reimbursement for LED lighting, chiller maintenance/repair, and boiler maintenance/repair. The energy saved from these upgrades will save the college money on annual energy costs.

Grant Overview: IGEN provides funding to its members for activities, programs, and projects for education and training in renewable energy and energy efficiency technology. Funds were used to purchase and install an electric vehicle charging station.

Funding from this grant will allow the project team to complete the OER textbook and make it available for courses in fall 2023.
