Summer 2020 Registration

Whether it is taking a general education class or a specific class for your major, you can use summer to help free up some time during the fall and spring semesters. Classes for summer will be mostly online and start May 18, June 15, and July 13, so we offer a variety of start dates to fit your schedule and needs. Some Health Professions and CTE courses with online instruction may require on-campus labs and clinical experiences for course completion. Registration for summer 2020 is now open. Fall 2020 Registration

Today marks the beginning of Fall 2020 registration for continuing students. Log into the student portal to view the days and times you are able register.
